f. DOLA Local Planning Capacity Grant

DOLA Local Planning Capacity Grant and guidance on the scopes and outcomes including:

- **DOLA is announcing new incentives for fast-track efforts** for the communities that implement before the November 2026 deadline; first-come/first-serve; especially if in the state's fiscal year of July 1-June 30th. **If fast-track is implemented the incentive includes additional supplemental funding (\$\$) for eligible/allowable uses.**
- **Project Description:** The Project is a multijurisdictional effort that consists of land use policy changes to expedite review of affordable housing projects, robust community engagement, and other planning efforts that generally advance affordable housing goals in the Town of Ignacio, Town of Bayfield, City of Durango, and La Plata County, Colorado.
- **Work Description:** The Town of Ignacio (Grantee) acting as lead fiscal agent, will engage previously hired, qualified consultants to explore, adopt, and implement land use policy amendments that seek to expedite review of affordable housing projects. Additionally, consultants will create a database for preservation of affordable housing, prepare a site inventory of potential properties and pursue funding for potential development of future affordable housing projects, prepare deed restrictions, facilitate regional collaboration between participating jurisdictions to achieve the region's affordable housing goals, and manage tracking and documentation of Prop 123-related efforts, such as local government commitments or fast track compliance.
- **Outcome:** The final outcome of this Grant is adoption of land use policy amendments and implementation of a system to expedite the development approval process for affordable housing projects, completion of site inventory and preservation database, documentation of community engagement efforts, and submission of any related reports or work product funded by this grant on behalf of the Town of Ignacio, Town of Bayfield, City of Durango, and La Plata County, Colorado. In addition, a Final Informal Memo will be submitted to DOLA as a Final Report.
- **1. Priority on fast-track** (expedited review) processes; Identify and **contract with a land use expert** to research and/develop land use best practices of a database of fast-track requirements; track all Prop 123 commitment activities and fast-track efforts.
- **2. Deed Restrictions/Resales contracted with New Communities Law and HomesFund** to develop standardized program that aligns with new state guidelines.

- **3. Engage stakeholders in effort to identify a permanent funding source**, this can include research/educational activities (no advocacy efforts) (S.T.E.E.R.)
