

### PROPOSITION 123

- In November 2022, Colorado voters approved Proposition 123 a ballot measure authorizing the state to retain from existing tax revenue to support affordable housing investment.
- These funds are split 60/40 between the office of Economic Development and International Trade (OEDIT) in partnership with Colorado Housing and Finance Authority (CHFA).




- Affordable Housing Support Fund

RHA awarded \$192,000 Prop 123 Local Capacity Planning Grant through Town of Ignacio as lead fiscal agent

## What is the RHA doing?



- ▶ Launch the RHA S.T.E.E.R. Committee
  - (Stakeholder Taskforce for Evaluation and Endorsement of Revenue- Streams) to explore local funding sources and if a public funding source is viable
  - RHA will host key partners and stakeholders to share the findings and recommendations of the S.T.E.R. Committee and build community awareness and support for a dedicated funding source
- Continue to strengthen RHA role of inter-county coordination and provide a unified approach to addressing the affordable housing shortage in La Plata County
  - RHA representation meetings and education forums
  - Strengthen partnerships
